<u>Call to order:</u> Meeting was called to order by Rousonelos at 0813 hours due to no quorum prior till.

Roll Call: Rousonelos, Anderson, Menard, and Jurica. Absent was Arellano, Ternes, & Chief Hertzmann. Non-Board Members in attendance included Dan Rozak and Andrew Mustoe.

Approval of Agenda: Anderson made a motion to approve the agenda for today, seconded by Menard, all in favor, none opposed.

Approval of Minutes: Jurica made a motion to approve the meeting minutes from November 2023, seconded by Menard, all in favor, none opposed.

Chairman's Report: President Rousonelos stated election ballots for the upcoming fiscal year will be sent out to all members today via email. Ballots must be received back by December 15th and will be tallied up at our January 2024 meeting. New Business: Anderson made motion to approve the revised by-laws draft. The draft was sent to all active board members for review. Motion was seconded by Menard. All the members in attendance voted yes.

Adam Menard made motion to purchase 16 Bunkroom Curtain/Rods and not to exceed Six Hundred Dollars. Motion was seconded by Jurica. All the members in attendance voted yes.

Anderson made a motion to purchase new kitchen drying matts, kitchen utensils, and Blackstone Equipment; not to exceed five hundred dollars. Motion was seconded by Menard. All the members in attendance voted yes.

Motion made by Rousonelos to approve each firehouse an allowance for \$1,000.00 every fiscal year kitchen utensils. This will begin May 1^{st} of 2024. Motion seconded by Menard. All the members in attendance voted yes.

Menard made a motion to purchase new shower matts for each firehouse; not to exceed 150.00. Motion was seconded by Jurica. All the members in attendance voted yes.

Anderson made a motion to purchase each firehouse coffee for daily and training purposes. Proposal is not to exceed \$1,000.00 from Costco, including the membership fee. Motion was seconded by Jurica. All the members in attendance voted yes.

Menard made a motion to purchase a new Titan Fitness Bar and workout towels for each firehouse; not to exceed \$500.00. Motion was seconded by Rousonelos. All the members in attendance voted yes.

Adjournment: Rousonelos made motion to adjourn the meeting, seconded by Anderson. All in favor, & none opposed. Meeting adjourned at 08:47 hours.
