

MINUTES OF A SPECIAL MEETING OF THE TROY FPD FIREFIGHTERS' PENSION FUND BOARD OF TRUSTEES MAY 22, 2023



A special meeting of the Troy FPD Firefighters' Pension Fund Board of Trustees was held on Monday, May 22, 2023 at 5:00 p.m. in Troy Fire Station 1 located at 700 Cottage Street, Shorewood, Illinois, 60404 pursuant to notice.

PLEDGE OF ALLEGIANCE: The Board stood and recited the Pledge of Allegiance.

CALL TO ORDER: Trustee Valkovich called the meeting to order at 5:01 p.m.

APPROVE COMBINED SERVICE REGULAR RETIRMENT BENEFITS – HOWARD HOFFMAN: The Board reviewed the combined service retirement benefit application with Troy FPD, Downers Grove Fire and Minooka FPD for Howard Hoffman prepared by L&A. Howard Hoffman had an entry date of August 2, 2013; retirement/termination date of June 9, 2023; effective date of combined pension is June 10, 2023; 58 years of age at date of retirement; 9 years and 10 months of

creditable service with Troy FPD; applicable salary of \$134,688.06; applicable pension percentage of 75%; amount of originally granted monthly pension of \$4,048.42; and amount of originally granted annual pension of \$48,581.05. A motion was made by Trustee Brownlow and seconded by Trustee Valkovich to approve the combined service retirement benefit for Howard Hoffman calculated by L&A. Motion carried by roll call vote.
